

# Terms and conditions of TemptingPlaces contest

### Article 1 : Organizing company

TemptingPlaces, number SIRET 50271368800021 whose head office is located at the following address Tour Voltaire, 1 Place des Degrés, 92800 Puteaux, organizes a free contest without obligation of purchase from May 31st, 2022 to June 7th, 2022.

### Article 2: Conditions of participation

- 2.1 This Game is open to any individual residing in Europe, customer or not with TemptingPlaces. The company reserves the right to proceed to all the necessary verifications concerning the identity, the postal and/or electronic address of the participants.
- 2.2 Are excluded from any participation in the present Contest and from the benefit of any endowment, that it is directly or indirectly the whole of the personnel of the Company and the Partners, including their family and spouses (marriage, P.A.C.S. or recognized marital life or not), as well as the minor persons.
- 2.3 Persons who have not provided proof of their full contact details and identity or who have provided them inaccurately or falsely will be disqualified, as will persons who refuse to accept the collection, recording and use of personal information concerning them that is strictly necessary for the purposes of managing the Contest.
- 2.4 Participation in the Contest implies full and unconditional acceptance of these rules. Failure to comply with these rules will result in the automatic cancellation of participation and the possible awarding of prizes.

### Article 3: Participation procedure

- 6.2 The prizes are not interchangeable for another object, nor for any monetary value and cannot give rise to a partial or total refund. Participants are informed that the sale or exchange of prizes is strictly prohibited.
- 6.3 The value indicated for the prize(s) corresponds to the current or estimated public price, including tax, on the date of drafting of the rules, and is given as a mere indication and is subject to variation. The Organizing Body cannot be held responsible for any incident/accident that may occur in the use of the prizes. # Article 7: Limitation of responsibility

The participation in the game "TemptingPlaces contest" implies the knowledge and the acceptance of the characteristics and the limits of the Internet, in particular as regards the technical performances, the response times to consult, question or transfer information, the risks of interruption, and more generally, the risks inherent in any connection and transmission on Internet, the absence of protection of certain data against possible hijackings and the risks of contamination by possible viruses circulating on the network. - e. delivery problems;
- f. the functioning of any software;

- h. any damage caused to a Participant's computer



- i. any technical, hardware or software failure of any kind that prevents or limits the possibility of participating in the Game or that damages a Participant's system

The organizer reserves the right to exclude permanently from the various games any person who, by his fraudulent behavior, would harm the smooth running of the games. In addition, the sponsorship of fictitious persons will result in the immediate elimination of the player. Similarly, any attempt to use the game outside the unmodified interface set up on the site will be considered an attempt at fraud. In addition, decompiling the Game, using personal scripts or any other method to circumvent the intended use of the Game as set forth in these rules will also be considered attempted fraud and will result in immediate elimination without recourse.

### Article 8: Registration of the rules

As of the date of its implementation, this Game is subject to the present rules, filed with the office of Maître COHEN-SKALLI-HOBA, bailiff located at 5 avenue Gabriel Péri BP42 93401 ST-OUEN CEDEX, France.

#### Article 9: Personal data
