The privacy and security of your information is very important to Hotel Ekta.

We want you to trust how we manage your information. This policy is intended to keep you informed in full transparency of how we use it to manage and organize your stay at our property. We are committed in our activities to protect the privacy of our customers and partners by ensuring the protection, confidentiality, and security of data in accordance with applicable legislation.

Each data processing carried out by the Data Controller pursues a legitimate, determined and explicit purpose. For each of the treatments implemented, our hotel undertakes to collect and use only adequate, relevant and limited data to what is necessary in relation to the purposes for which they are processed. We ensure that the data is kept up to date and implement processes to enable the deletion or rectification of inaccurate data.

Recipients of personal data

This information is not sold or communicated to third parties and is strictly reserved for the internal uses described above.

Our establishment ensures that only authorized persons can access the personal data of our customers, i.e. our employees subject to an obligation of confidentiality as well as our partners and service providers for the performance of our services.

Some personal data may be sent to third parties to meet legal, regulatory or contractual obligations or to legally authorized authorities (prefecture of police, mayor of Paris, obligations under the Fight against Money Laundering and Financing of Terrorism, Tracfin declaration, etc.).

Depending on your request, we may be required to transmit personal data to third parties in order to subscribe to products and services from these third parties (reservation of restaurant, private car, travel or shows). The customer is informed that we are only responsible for our own data processing and that therefore customers are invited to contact the third party recipients to be informed of the terms and conditions of any processing carried out.

Outsourcing

When we need to use a provider, we ensure that the provider provides guarantees on its ability to meet these security and confidentiality requirements.

In compliance with our legal and regulatory obligations, we conclude contracts with our subcontractors that precisely define the terms and conditions for the processing of personal data by them, in accordance with the regulations on the protection of personal data.

Lawfulness of processing

The EKTA Hotel and each of its employees are prohibited from processing data collected unlawfully.

The processing is legal if at least one of the following conditions is met:

- the person has consented to the processing of his or her personal data for one or more specific purposes.
- the processing is necessary for the performance of a contract to which the data subject is a party or for the performance of pre-contractual measures taken at the request of the data subject.
- the processing is necessary for compliance with a legal obligation to which the EKTA hotel is subject.
- processing is necessary to protect the vital interests of the data subject or of another natural person.
- the processing is necessary for the purposes of the legitimate interests pursued by Hotel EKTA

You have rights over your data

Persons whose data are processed have the following rights, unless otherwise required by law:

- the right to information
- the right of access

- the right to rectification
- the right to erasure or the right to be forgotten
- the right to transfer
- the right to object
- the right to restriction of processing

You have the right to access a copy of the Data we hold about you.
